**Item 1:**

a **Attached.** This Situation / Problem Log is used as a generic form for any problems reported. If the documents you are requesting (1b – 1g) for election day support, reporting, tracking, transport, & canvassing are specifically for voting machines, then there are no documents that exist for this.

**Item 2:**

**Attached.** This document shows the assignment of voting machines in precinct 231 in the April 8<sup>th</sup> Runoff Election, which is the election I assume you are interested in. There is no document that shows assignment of PEBs or Flash Cards to iVotronic machines in precinct 231 other than the information being on the PEBs and Flash cards themselves.

**Item 3:**

Audit Logs for precinct 231, as you know, are printed from information on flash cards, but due to an ongoing election contest, these flash cards are secured by the court thus making it impossible to comply with this request at the present time.
