- C. Order any other just and equitable relief.





**FINDINGS OF FACT AND  
 CONCLUSIONS OF LAW**

THIS MATTER having come on regularly for hearing on the day of November, 1985, upon the Petition for Dissolution of Marriage filed herein by Jeffrey W.
